#### ACCORDINGLY, IT IS ORDERED THAT:

- the Appellant, Her Majesty the Queen in Right of Newfoundland and Labrador (File No. 2019 01H 0099), is granted leave to appeal on the ground of whether a cause of action is disclosed as against it based on the grounds set out in paragraph 5, item 1 of the decision, and
- 2. the Appellant, Nalcor Energy (File No. 2019 01H 0100), is granted leave to appeal on the ground of whether a cause of action is disclosed as against it based on the application of the law and legal principles to the facts as pleaded.
